A. Objective

The objective of the survey was to get information on how the MGNREGA scheme is being implemented for the development of SC/ST community under SCSP/TSP Action Plan. A total budget outlay of Rs 605.33 creach was allotted for the year 2019-20 and 2020-21 for providing work to SC/ST daily wage workers under MGNREGA from SCSP/TSP Action Plan. This constitutes 33% of the overall budget of the rural development department for MGNREGA and hence a need to study its impact on the marginalised SC/ST community.

B. Methodology

The Joint / Deputy Director of Social Welfare Department was allowed to select 10 Gram Panchayats, with the highest SC / ST population. The selected Gram Panchayats had minimum three villages. In each village, minimum five SC/ST job card holders were interviewed (15 members in the Gram Panchayat -10 Scheduled Caste & 05 Scheduled Tribe) and information was uploaded in the separate web application created for the purpose.

The survey was conducted by Taluk Assistant Director and his/her team. Help of Hostel superintendents and ashrama schoolteacherswere also used for conducting survey. Detailed questionnaires is attached as annexures.

C. Findings and Analysis

1. No. of beneficiaries

A total 6,282 MGNREGA beneficiaries were interviewed and data collected. 3,547 (56%) SC beneficiaries, 1,293(21%) ST beneficiaries and 1,442 (23%) other beneficiaries (which can be categorised into SC/ST) were interviewed.





2. Awareness of the Scheme

- 6,107 (97%) of the beneficiaries have claimed to be **aware** about the scheme. 175(3%) were found to be **notaware** of the scheme
- Out of these 175 who were not aware, 146 (83%) did not apply for work and 29 (17%) applied for work
- Out of these 175 who were not aware, 162 (93%) said awareness program was **notconducted** and 13 (7%) said awareness program was conducted





• A total of **700** (**11**%) beneficiaries out of 6,282 have said **no awareness program** was conducted in their village/GP.

3. Not applied for employment

- A Total of 685(11%) beneficiary out of 6, 282 have said they have not applied for work
- In Kodagu, 100 (60%) beneficiaries out of total 166 surveyed have not applied for work
- In Ramanagara, 58 (33%) beneficiaries out of total 175 surveyed have not applied for work
- In Mandya, 54 (35%) beneficiaries out of total 154 surveyed have not applied for work

 Gadag, Bengaluru urban, Kodagu are some of the districts where the percentage of beneficiaries not receiving 100 days' work is more than 90%.



• Out of 2,694, only 79 people claimed to have received unemployment allowance





7. Bank Account

- Out of 6,282, only 84 (1%) people claimed to not have opened Bank/Post office account for wages to be received under MGNREGA programme
- Out of 84, 12 people claimed to receive benefits in cash



8. Wages provided within 7-15 days

- Out of 6,282, 5,696(91%) have received wages within 7-15 days and 586 not received within 7-15 days
- Out of 586, 38 people have claimed to have received payment in more than 50 days




9. Economic status

• Out of 6,282, 5,065 (81%) of people have claimed that economic status of their family has improved after implementation of MGNREGA



10. Agricultural land

- Out of all 6,282 beneficiaries 52% own agriculture land and 48 % did not own agricultural land
- 44% have received work in their own land



D. Recommendations

- Awareness of the program need to be increased especially in districts like Kodagu,
 Mysuru and Mandya where 35%, 30% and 26 % of the respondents respectively
 reported that they were not aware of the program.
- Reasons for not applying for work needs to be inspected as 11% of the respondents in the state have not applied for work which is highest of 60% in Kodagu and 35% in Mandya district
- Though it is mandated under the law, 66% of the respondents did not receive minimum 100 days of employment. No. of workdays for SC/ST need to be increased.
- Unemployment allowance need to be disbursed immediately to SC/STs as only 57%
 of the respondents were aware and only 79 people claimed to have received
 unemployment allowance in the state
- Application process should be streamlined and made simple as 26% of the respondents did not receive work within 15 days of applying though it is mandated by law
- Make sure everybody who works under MGNREGA has a functioning bank account
- There should not be any delay in payment of wages as 9 % of the respondents have reported to have not received payment within 7-15 days of completion of work as mandated by law
- 81% of the respondents have reported that MGNREGA has improved their economic status but 19% have said it has not improved. Reasons for this need to be explored.
- MGNREGA work in own agricultural land needs to increase as just 44% of the respondents have received work in their own land. It is reported to increase savings for the beneficiary.
